INTRODUCTION

- Nevis has its own deflationary cryptocurrency token on the Binance Smart Chain (BSC) known as **“NEVIS TOKEN”**
- NEVIS TOKEN is listed on PancakeSwap, the largest decentralized exchange in the world.
- Nevis also has its own staking platform know as **“NEVIS TREASURE”**. Where a person can lend his USDT stablecoin or BNB to the platform and in exchange receive monthly fixed rewards in USDT stablecoin or BNB.

NEVIS TOKEN

- The NEVIS TOKEN is traded on Pancakeswap, which is one of the largest decentralized exchange in the world.
- There is a **5% fee** charged every time the token is bought or sold, which is directly added to the NEVIS PLATFORM as its revenue.

NEVIS STAKING

The investors have the option to choose a staking contract duration of **90, 180, or 360 days**, allowing you to tailor your staking strategy according to your preferences.

Under this arrangement, you will receive monthly rewards for your staked funds, with the principal amount being returned to you upon the completion of the selected contract term.

BUSINESS MODEL

Here's how the NEVIS TREASURE works. Unlike traditional banks run by governments, decentralized finance allows multiple ways to generate revenue, due to blockchain technology and its transparent systems.

NEVIS operates with two liquidity pools: **USDT/NEVIS LP** and **BNB/NEVIS LP**. When someone stakes USDT or BNB in the NEVIS TREASURE, the funds are used to purchase NEVIS TOKEN and added to the corresponding liquidity pool of NEVIS.

The price of BNB in the LP fluctuates with the buying and selling of the NEVIS token which creates an arbitrage opportunity for BNB.

Trading bots see this opportunity and trade with the NEVIS TOKEN and in turn give 5% fee to the treasury.

This buying and selling of the NEVIS TOKEN itself creates revenue for the NEVIS TREASURE on a regular basis. The profits generated through this process are further shared to those who have staked their USDT or BNB which yields them higher rewards.

EXAMPLE

1. USDT / NEVIS Liquidity Pool

$1000 \text{ USDT} / 10 \text{ NEVIS} = 100$ (Price of 1 NEVIS)

2. BNB / NEVIS Liquidity Pool

Price of 1 BNB = \$200

$5 \text{ BNB } (\$1000) / 10 \text{ NEVIS} = 100$ (Price of 1 NEVIS)

Now BNB fluctuates on external factors, if the price of BNB goes to \$225 the value of NEVIS increases in the Liquidity Pool

$5 \text{ BNB } (\$1125) / 10 \text{ NEVIS} = 112.5$ (Price of 1 NEVIS)

The price in the USDT/NEVIS LP is 100 & the price in the BNB/NEVIS LP is 112.5

Seeing this difference, the bots come and trade the NEVIS token, as the NEVIS token charges a 5% fee, the bot earns 2.5% and in turn gives the platform 10% in revenue.

FLOW OF FUNDS



NEVIS TREASURE - CONTRACT TERM

There are 3 contract terms for USDT and BNB.

- 1. 90 Days - up to 3% pm** : The 90-day contract offers a monthly reward of up to **3%**, resulting in a total return of up to **9%** over the course of 90 days.
- 2. 180 Days - up to 4% pm** : The 180-day contract offers a monthly reward of up to **4%**, resulting in a total return of up to **24%** over the course of 180 days.
- 3. 360 Days - up to 5% pm** : The 360-day contract offers a monthly reward of up to **5%**, resulting in a total return of up to **60%** over the course of 360 days.

Note: The option to unstake your principal amount is available exclusively upon the completion of the contract only.

NEVIS TREASURE - STAKING PANEL

The staking panel consists of :

1. **Term** : 90, 180, 360 days.
2. **Reward** : up to 3%pm , 4%pm, 5%pm.
3. **Staked** : The total amount staked by you.
4. **Claimed Rewards** : The total rewards that have been claimed.

NEVIS TREASURE - ENTRIES

Whenever you stake, an entry is generated and can be located below the staking panel.

The subsequent details are presented:

- 1. Date & time** : The date & time at which you have invested.
- 2. Amount** : The amount which you have invested.
- 3. Term** : The contract you have selected.
- 4. End date & time** : When the contract would end.
- 5. Rewards** : Total rewards available to claim.
- 6. Claim** : Click the claim button to withdraw your rewards.
- 7. Unstake** : Once you click on Unstake, the button will change to **COMPLETE**. The option to unstake your principal amount is available exclusively upon the completion of the contract.
